WWII, U. S. Marine Corps***



*Donna was born on a Texas farm in the Valley in Lyford, Texas. Her family, which included three sisters, moved to Edinburg, Texas when she was a child. She graduated from high school in Edinburg and went to work for Southwestern Bell Telephone Company as a telephone operator.*

*Donna is a widow and has three children and one grandchild. One daughter is a gift shop owner and painting artist in Pflugerville. The other daughter is an actress in Hollywood. Her son is a truck driver in Manor, Texas*

*Donna's church friend, housemate and caretaker of ten years Jo Bobbit takes very good care of her and keeps things neat and orderly in Donna's home.*

*Donna entered the Marine Corps in 1944. She was stationed in Washington, D. C. and worked as a typist in the casualty department. She was also stationed in Hawaii and San Francisco where she was a telephone operator. In 1946 she was honorably discharged because the war ended.*

*Years later Donna served ten years in the Marine Corps Honor Guard where she was one of the 21-gun salute squad members. The squad served at funerals and ceremonies. (She jokes she can barely lift the rifle now).*

*Donna was the only woman ever to serve in the Marine Corps Honor Guard.*

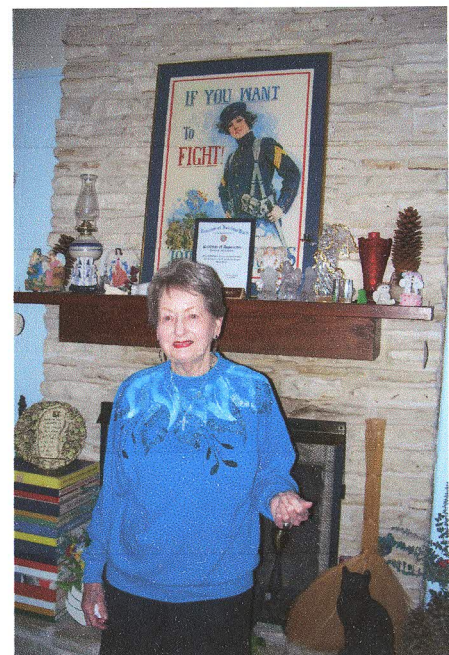
*Donna's civilian jobs include seven years at Southwestern Bell and twenty years at the Texas Animal Health Commission as an accountant. She retired in 1974.*
